

- 3. The representative of the appellant states that he has received the complete information and compensation amounting to Rs.10,000/- except the copy of four affidavits related to the mutation. He has also sent the written submissions which are taken on record. However, the respondent-Public Information Officer states that the reply has already been sent to the Commission by way of an affidavit as no affidavits are available in the official record.
- 4. The reply filed by the respondent-Public Information Officer is reproduced below:-
 - That during the hearing of the abovesaid Appeal Case No. 3953 of 2020 before this
 Hon'ble Commission on 1st July, 2021, I have stated that four affidavits relating to the
 mutation case of appellant and the reference of which have been given in the
 mutation-sheet(Part-Sarkar) are not available in the official record.
 - 2. That in compliance with the orders dated 1st July, 2021 of this Hon'ble Commission, now it is submitted that a copy of mutation No. 848 of village Majhwind relating to the transfer of ownership on the basis of orders dated 8.1.2018 passed by the Hon'ble High Court of Punjab and Haryana, Chandigarh in RSA No. 1669 of 1993 has been supplied to Shri Jagir Singh, appellant/applicant and according to the order dated 31.8.2008 of Shri Ajay Kumar, Naib Tehsildar, Majitha as Assistant Collector Hind Grade passed on the mutation-sheet (Part-Sarkar), the documents produced by the parties concerned had been seen by him and returned to the parties. As such, it is again submitted that four affidavits in question are not available in the official record of Tehsil Majitha.

5. As far as the request of the appellant regarding enhancement of the compensation and imposing of the penalty is concerned, although there is no limit prescribed under the provisions of the RTI Act, 2005 to award the compensation, as the sufficient compensation has already been awarded to the appellant as per the provisions of the RTI Act, 2005, the request of the appellant is not accepted to enhance the compensation.

Regarding imposition of the penalty upon the respondent-Public Information Officer, due to Covid 19 pandemic, lock down and as per the directions of the Government to work with 50% staff, no penalty provisions have been invoked.

- 6. However, the order of the Commission dated 27.5.2021 was also sent to the Deputy Commissioner, District Amritsar and the relevant portion of the same is reproduced below:-
 - "7. It is apparent that the harassment has been caused to the appellant regarding entry of Intkal No. 848 in the Jamabandi 2018-2019 due to non handing over of the official record and non dealing of his application regarding entry of intkal No. 848. Keeping in view the mandate of RTI Act, 2005 i.e. transparency and accountability, it appears to be a fit case to fix the responsibility & take necessary action as per law. Hence a copy of this order is being **sent** to the Deputy Commissioner, Amritsar for information in this regard."

Now, the another facet of the case has emerged that the copies of the four affidavit relating to the mutation case of the appellant reference of which has been given in the mutation-sheet(Part-Sarkar) are not available in the official record which indeed is a serious matter and the present Public Information Officer-cum-Naib Tehsildar, Majitha has filed an affidavit in this regard.

Accordingly, the copy of this order is again **sent** to the Deputy Commissioner, District Amritsar along with a copy of the case file, to look into matter and fix responsibility to ensure that the mandate of the RTI Act, 2005 i.e. transparency and accountability is fulfilled.

7. Keeping in view the above, the Commission observes that no further action is required to be taken in this case in accordance with the provisions of the RTI Act, 2005, as

the respondent authority has already filed the specific reply pertaining to the deficiency pointed out by the appellant. Therefore, the case is disposed of and closed.





It is also a fact on record that the respondent authority has already sent the information, which is being **sent** along with this order to the appelant.
