asking them to provide the information concerning to their offices directly to the appellant. The appellant has stated that he has received no information. The Commission deems it fit to serve Show Cause Notices to the aforesaid officers who are all deemed PIOs in this case as per section 5(4) and 5(5) of the RTI Act 2005.

3. The respondent PIOs, Senior Town Planner, Municipal Corporation, Ludhiana, Superintendent Engineer, GLADA, Ludhiana, District Fire Officer, Municipal Corporation, Ludhiana., and Naib Tehslidar, GLADA, Ludhiana, is herewith ordered to SHOW CAUSE as to why a penalty should not be imposed upon him under Section 20 (1) of RTI Act, 2005, for causing willful delay/denial of the information requested by the appellant as far back as on 9.4.2019.

"In addition to the written reply, the respondent PIO is also given an opportunity under Section 20 (1) provision there to, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him *ex parte*." Copies of this order be sent to the parties through registered post.
