

- 6. Due to the contradiction, the appellant further submits that the respondent-Public Information Officer may be penalized as the respondent delayed the information deliberately. But the respondent-Public Information Officer submits that the appellant filed the RTI application on 11.9.2021 She also submits that the appellant filed the RTI application to the Deputy Commissioner, Amritsar and the Deputy Commissioner, Amritsar transferred the RTI application to the S.D.M. Amritsar-1 who has further transferred the RTI application to the Tehsildar, Amritsar-1 being the custodian of the record. 


