- 1. The RTI application is dated **16.7.2021** vide which the appellant has sought information <u>regarding Letter No.153/ATP/A/D dated 14.7.2021</u>, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **28.9.2021** and Second Appeal was filed in the Commission on **17.12.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **21.7.2022**.
- 2. Both parties are present. The appellant has pointed out in a written submission to this Commission that two separate replies received from the respondent PIO vide Letter No. 821 Dated 3.12.2021 and 125 Dated 18.7.2021 are mutually contradictory. The first letter states that the information pertaining to points 2, 3, 4, and 5 of the RTI application is appended to said reply. However, no information was received therewith. The reply received vide Letter No. 125 Dated 18.7.2022 states that the information requested at point no. 2, 3, 4, and 5 is not available in the record. The above appears to suggest that the respondent PIO is attempting to withhold / deny the requested information in violation of the RTI Act, 2005. In view of the above Commission deems it fit to serve the respondent PIO, Zone A, MC, Ludhiana, with this Show Cause Notice.
- 3. The respondent <u>PIO-cum-ATP</u>, <u>Sh. Sunil Kumar</u>, <u>Zone A</u>, <u>MC</u>, <u>Ludhiana</u>, is herewith ordered to <u>SHOW CAUSE</u> as to why a penalty should not be imposed upon him under Section 20 (1) of RTI Act, 2005, for causing willful delay/denial of the information requested by the appellant as far back as on **16.7.2021**.

The Commission notes that this RTI application was submitted to the PIO-cum-Superintendent, Headquarters, MC, Ludhiana and it appears that said PIO has failed to transfer the portion of the application pertains to point no. 6, 7 and 8 to the office of MTP, MC, Ludhiana. In view of this, the Commission deems it fit to issue a Show Cause Notice to the PIO-cum-Superintendent Headquarters, MC, Ludhiana.
- 5. The respondent <u>PIO-cum-Superintendent Headquarters, MC, Ludhiana</u>, is herewith ordered to **SHOW CAUSE** as to why a penalty should not be imposed upon him under Section 20 (1) of RTI Act, 2005, for causing willful delay/denial of the information requested by the appellant as far back as on **16.7.2021**.
