Thereafter, the appellant filed the 2<sup>nd</sup> appeal before the Commission on 10.12.2021.

4. Keeping in view the submissions made by the respondent, he requested to withdraw the penalty imposed upon the PIO and the compensation awarded in this case.

5. After the perusal of the submissions made by the respondent and going through the record available in the case file, the orders concerning the penalty imposed upon the PIO amounting to Rs.10,000/- (Rupees Ten thousand only) and compensation amounting to Rs.5000/- awarded in favour of the appellant are hereby withdrawn.

#### ORDER

This order may be read with reference to the previous order dated 8.8.2022. The case was earlier heard by the bench of Sh. SanjivGarg, SIC but due to administrative reasons the case was reallocated to this bench and fixed for hearing today.

2. The complainant requested that the directions may be issued to the respondent-Public Information Officer to provide the complete information.

3. It is appropriate to mention that Hon'ble Supreme Court of India in its order rendered on 12.12.2011 in Civil Appeal Nos.10787 – 10788 of 2011 (arising out of SLP @ No.32768-32769/2010) has held that while entertaining a complaint under Section 18 of the RTI Act, 2005, the Commissioners have no jurisdiction to pass an order providing for an access to the information. Since the complainant has approached the Commission under the provisions of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission.

An alternative and efficacious remedy of first appeal is available to the complainant under Section 19(1) of the RTI Act, 2005 which has not been availed in the instant case. Since the complainant is interested in getting the information, therefore, the matter is remanded back to Sh. Sandeep Singh Ramana, Superintending Engineer-cum-First Appellate Authority to take appropriate decision in accordance with the
