1. The RTI application is dated **28.8.2020** vide which the appellant has sought information **regarding vehicle dealerships in Zone-A, B, C and D**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **28.9.2020**, and Second Appeal was filed in the Commission on **24.11.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **2.7.2021**.

2. The appellant is absent without intimation for the third time in succession. The Commission concurs with the respondents that the volume involved is considerable and would amount to a disproportionate diversion of public resources.
