1. The RTI application is dated **20.7.2020** vide which the appellant has sought information regarding an enquiry conducted by ADC (D) Fazilka against DDPO Fazilka etc., as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **21.8.2020**, and second appeal was filed in the Commission on **14.10.2020** under Section 19 of the Right to Information Act, 2005. Notice to the parties for first hearing was issued on **3.2.2021**.

2. Both parties are present through Video Conference Facility at Deputy Commissioner Office Fazilka. The appellant is represented by his lawyer, Prem Singh. The respondent PIO, represented by Vikrant Setia, clerk, stated that a reply was first sent to the appellant on 29.9.2020, stating that the matter cited in the RTI application was still under investigation. The respondent has again contended at this hearing that the matter is still under investigation and the requested information will be supplied to the appellant when the investigation is over.

3. This Commission notes that the enquiry cited in the RTI application has been pending since 28.11.2019, which is more than one year. This Commission strongly recommends that ADC (D) Fazilka expedite the completion of the said enquiry and submit his report at the earliest, so that the requested information can be furnished.

4. Under the circumstances, there is no further cause for action and this appeal case is herewith **CLOSED**.
