4. The conduct of the PIO amounts to denial of information and violation of provisions of the RTI Act and so why show cause notice is not issued to the PIO for not providing the information within stipulated time to the appellant. The appellant is suffering for the last about three years, so compensation must be awarded. The PIO is further directed to be present in person on the next date of hearing.

5. The appellant is suffering since long as the PIO is not providing him information. So, a compensation of Rs.5000/- is hereby awarded. The compensation shall be paid by the public authority concerned by way of cross cheque / demand draft in the name of the appellant Shri Ahswani Kumar. The cross cheque/demand draft shall be made from the bank account of the public authority concerned and not from the individual officer. The respondent PIO is also directed to produce a copy of the cross cheque / demand draft in the commission on the next date of hearing to establish the fact that the order of the commission has been complied with..
