2. The respondent orally states that pursuant to orders of Commission, the original affidavit after getting notarised from the public notary has already been supplied to the appellant on 04-3-03-2021.

3. The Appellant is absent today with no intimation to Commission. He was also absent on the previous date of hearing on 20-05-2021. It is presumed that he has received the original affidavit, duly notarised, from the respondents and he is satisfied with the same.

4. In view of the above, **the case is ordered to be disposed of and closed.** Copies of order may be sent to the parties.
