She again did not come for inspection on 17.12.2018. PIO/Respondent was directed to ensure the inspection of record on 17.12.2018.

The Appellant Ms. Sharuti is absent today without any intimation.

Today Ms. Kashish Garg, Building Inspector from Zone-B comes present. She submits letter dated 30.01.2019 in the Court, which is taken on record.

#### Appeal Case No. 2094 of 2018

It is informed vide this letter that as directed by the Court, the Appellant was called for inspection of record to see the information she seeks on 21.11.2018 and also thereafter, she was given opportunity to inspect the record to get the requisite information on 17.12.2018 but she did not visit to inspect the record nor she has given any intimation for not coming to inspect the record.

The Appellant was absent on the last date of hearing and again is absent today. The appellant was given last opportunity to visit the office of PIO/ Respondent to inspect the record on 17.12.2018 and to see the information required by her but she never visited to inspect the record nor she has deposited Rs.7900/- the cost of information comprising 3950 pages, asked for vide letter dated 09.04.2018. It is presumed that she is not interested in inspecting the record and getting the information.

In view of above, no further cause of action survives. **The appeal is disposed of and** the case is closed.
