



This order may be read with reference to the previous order dated 08.01.2020 vide which PIO/Naib Tehsildar, Dehlon, District Ludhiana stated that Hon'ble High Court of Punjab and Haryana has granted stay. No action regarding measurement of pond can be done due to stay. The matter was also brought to the notice of complainant in the presence of some reputed persons including Sarpanch. It is also mentioned in that, complete information as per its availability in the record has been provided to him and nothing has been left which could be supplied to him under the provisions of RTI Act, 2005.

- 2. The respondent-PIO states that complete information has been provided to the complainant concerning points at Sr. No.2 to 4 which relates to the concerned panchayat and regarding point at Sr. No.1, the information regarding demarcation of pond could not be supplied as the Hon'ble Punjab and Haryana High Court has stayed the matter as status quo.
- 3. The appellant is satisfied with the reply given by the complainant.
- 4. After hearing both the parties and going through the record available on the case file, it is revealed that information pertaining to points at Sr. No.2 to 4 has been given to the satisfaction of the complainant and information concerning point at Sr. No.1 could not be provided as the matter is stayed by Hon'ble High Court. Nothing more can be done under RTI Act, 2005. Accordingly, the present case is disposed of and closed. Copies of the order be sent to the parties.
