**Appeal case No.3280 of 2020**

**ORDER:**

The appellant through RTI application dated 17.09.2019 has sought information regarding action taken on the applications of the applicant by Director and LG-II alongwith noting and other information as enumerated in the RTI application concerning the office of Superintendent, LG-2, Local Govt. Pb Chandigarh. The appellant was not provided the information after which the appellant filed first appeal before the First appellate Authority on 01.06.2020 which took no decision on the appeal.

The case has come up for hearing today through video conferencing at DAC Ludhiana. The respondent present pleaded that since the information sought by the appellant was not specific, the appellant was asked vide letter dated 20.12.2029 to specify the information which was not specified.

The appellant claims that the information has already been specified vide his letter dated 11.02.2020. The respondent has brought information regarding point number 5 and handed it over to the appellant. The respondent further informed that the information regarding point-6 relates to Trust Service Cell O/o Directorate Local Govt. Pb Chandigarh.

Having gone through the RTI application and hearing both the parties, the PIO is directed to provide the remaining information (pointwise) to the appellant within 15 days and send a compliance report to the Commission.

The PIO-Trust Service Cell, Directorate of Local Govt. Pb Chandigarh is impleaded in the case and directed to provide the information on point-6

**ORDER:**

The appellant through RTI application dated 19.03.2020 has sought information regarding comments/correspondence from higher authorities on the applicant complaint dated 29.12.2019 filed to Secy School Education Punjab and on the civil writ petition filed by the applicant and other information as enumerated in the RTI application from the office of Director NCERT Pb Chandigarh which transferred the RTI application u/s 6(3) to DEO(EE) Ludhiana. The appellant was not provided the information after which the appellant filed first appeal before the First appellate Authority on 07.07.2020 which took no decision on the appeal.

The case has come up for hearing today through video conferencing at DAC Ludhiana. The respondent present pleaded that the information is available with the office of Directorate of School Education since the complaint was filed with the Secretary School Education.
