2. Observation:

Appellant is absent without any intimation to the Commission. Respondent, Sh. Kawar Surteg stated that sought information is a third party information which is exempted u/s 8(1)j of RTI act.

Appeal Case No.5047 of 2021 (Cisco Webex Proceedings)

The Commission agrees with the contention of the CPIO that such information is purely in the nature of personal information and no larger public interest has been shown.

Reference is drawn to the decision dated 13.11.2019 of the Hon'ble Supreme Court in the matter of Central Public Information Officer... vs Subhash Chandra Agarwal, the relevant paragraph relating to interpretation of personal information reads as follows:

36. If one's right to know is absolute, then the same may invade another's right to privacy and breach confidentiality, and, therefore, the former right has to be harmonised with the need for personal privacy, confidentiality of information and effective governance......

59. Reading of the aforesaid judicial precedents, in our opinion, would indicate that personal records, including name, address, physical, mental and psychological status, marks obtained, grades and answer sheets, are all treated as personal information. Similarly, professional records, including qualification, performance, evaluation reports, ACRs, disciplinary proceedings, etc. are all personal information. Medical records, treatment, choice of medicine, list of hospitals and doctors visited, findings recorded, including that of the family members, information relating to assets, liabilities, income tax returns, details of investments, lending and borrowing, etc. are personal information is entitled to protection from unwarranted invasion of privacy and conditional access is available when stipulation of larger public interest is satisfied. This list is indicative and not exhaustive.

3. Decision:

In view of the above observations and also the judicial dicta mentioned above, the Commission is not inclined to direct disclosure of information. The reply of the PIO dated 30.03.2022 is considered proper. No further action is required in the matter.

The appeal is disposed of accordingly.

- 2. Both the parties are present and heard.
- 3. The Commission, after hearing the submissions of both the parties and perusing the records, observes that the appellant vide points of the RTI application is seeking a certified copies of his own documents/emails submitted by him, which he is not entitled to seek as a matter of right under the RTI Act.

In this regard, the Hon'ble Madras High Court in the case of High Court, Madras vs. Central Information Commission, Writ Petition No. 26781/2013 dated 17.09.2014 has held as follows:-

".....we fail to understand as to how the second respondent is entitled to justify his claim for seeking the copies of his complaints and appeals. It is needless to say that they are not the information available within the knowledge of the petitioner; on the other hand, admittedly, they are the documents of the second respondent himself, and therefore, if he does not have copies of the same, he has to blame himself and he cannot seek those details as a matter of right Further, those documents cannot be brought under the definition "information" as defined under Section 2(f) of the RTI Act." In view of the above ratio, information sought cannot be provided to the appellant.

4. With the above observations, the appeal is disposed of.



2. The respondents have cogently and persuasively argued that the information as requested by the appellant, comes within the ambit of the exemptions under Section 8(1)(h) and 8(1)(g) of the RTI Act. Both these Sections prohibit disclosure of information connected with ongoing investigations and prosecutions and, information disclosure of which would compromise the source of the information of law enforcement authorities and could jeopardize the life or physical safety of those providing such tip-offs.

3. In the light of the aforementioned settled position of law, this Commission is of the considered opinion that the contention of the respondent is found reasonable and there appears no reason to interfere with the same. **The replies of respondents upheld. The matter is disposed of accordingly at Commission's end**. The appellant is at liberty to obtain necessary information from the respondent Authority at the appropriate stage/ or on the completion of the enquiry.
