ORDER

Heard through facility of Software/application 'CISCO Webex Meetings'.

The RTI request is dated 21.09.2020. First appeal is dated 19.10.2020. Second appeal has been received in the Commission on 28.12.2020.

On the last date of hearing, held on 06.04.2021, the appellant was advised to visit the office of the respondent PIO to inspect the relevant official record on 07.04.2021 identify the information. The respondent PIO concerned was directed to facilitate the appellant to inspect the relevant official record during his visit to the office and directed to supply the required information to the appellant, which would be identified by him after inspection. An opportunity was also given to the appellant to point out deficiencies, if any, in the information, which would be supplied to him, in writing, to the respondent PIO well in time so that the same could be removed by the respondent concerned.

Ms. Parminder Kaur, Senior Assistant, who appeared on behalf of the respondent PIO in today's hearing, states that in response to the RTI request, complete information has been supplied to the appellant vide letter no. 960 dated 09.10.2020 and again vide letter no. 3166 dated 07.04.2021. He also intimates the Commission that a reply has also been sent to the Commission through an e-mail. It, alongwith a copy of supplied information, is taken on record.

The appellant, Sh. Prem Kumar Rattan, who appeared in person in today's hearing, states that the information supplied is not satisfactory.

After going through the queries raised by the appellant, Sh. Prem Kumar Rattan through his RTI request and the response given by the respondent PIO concerned, it is found that the information supplied by the respondent PIO to the appellant is as per queries raised by him through RTI request.

As the required information has been supplied and no further action is left in the instant appeal case, hence, the case is announced as **disposed of and closed.**
