their own appellate authority, PIOs and APIOs appointed out the RTI act and information is based on multiple slums and poor colonies and have to be gathered or to be transferred under Section 6(3) of RTI Act.

3. On the above issue, attention is invited to instructions conveyed vide letter No. 10/2/2008-IR dated 12.6.2008(copy enclosed) by Director, Ministry of Personnel, Public Grievances and Pensions, Department of Personnel and Training, Govt. of India. The relevant part of these instructions is reproduced as under:-

“If no part of the information sought, is available with it but is scatter with more than one other public authorities, the Public Information Officer should inform the applicant that information is not available with the public authority and that the applicant should make separate applications to the concerned public authorities for obtaining information from them. It may be noted that the Act required the supply of such information only which already exists and is held by the public authority or held under the control of the public authority. It is beyond the scope of the Act for a public authority to create information, Collection of Information, parts of which are available with different public authorities, would amount to creation of information which a public authority under the Act is not required to do. At the same time, since the information is not related to any one particular public authority, it is not the case where application should be transferred under sub-section 3(3) of Section 6 of the Act. It is pertinent to note that sub-section (3) refers to ‘another public authority’ and not ‘other public authorities’. Use of singular form in the Act in this regard is important to note.”

Further, the Government of India order on the observation of Hon’ble Supreme Court on Right to Information Act, 2005 in Civil appeal No. 6454 of 2011, arising out of SLP C(c) No. 7526/2009 in the case of Central Board of Secondary Education and others Vs Aditya Bandopadhyay and others on this issue is also

“If a public authority has any information in the form of data or analysed data, or abstracts, or statistics, an applicant may access such information, subject to the exemptions in section 8 of the Act. But where the information sought is not a part of the record of a public authority, and where such information is not required to be maintained under any law or the rules or regulations of the public authority, the Act does not cast an obligation upon the public authority, to collect or collate such non available information and then furnish it to an applicant.”

5. In view of the position stated above, the Public Information Officer of PSULM office had transferred your RTI application to one ULBs namely Municipal Corporation Mohali as you are residing in the Mohali District PSULM office letter No. 1600 dated 16.12.2020 and further Municipal Corporation Mohali has also supplied the information pertaining to Municipal Corporation Mohali to you vide their letter No. 45 dated 27.1.2021.

In regard to the information regarding list of Slum colonies requested by you in other cities in Punjab, it is to inform that the complete list of the slub/poor colonies along with the basic amenities may be available in the respective Urban Local Bodies who have their own appellate authority, Public Information Officer and APIO under RTI Act. However, information of the slub colonies (50 pages) received from various ULBs through email from Commissioner Municipal Corporations (CMCs) and Regional Deputy Director, Local Government (DDRs) is enclosed in the form as received from Urban Local Bodies.”

4. The respondents have also sent the additional submissions vide letter dated 29.6.2021 and the relevant portion of the same is reproduced below:-

“It is informed that slums are developed by the migrant population of their own by encroaching the Govt./private land, therefore, being unapproved and unplanned, they develop without basic amenities. But now the Govt. of Punjab enacted “The

4. It is appropriate to mention the instructions issued by the Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training vide No.I/7/2009-IR dated 1.6.2009

"Decision dated 3.4.2008 of the High Court of Bombay at Goa in Writ Petition No. 419 of 2007 in the case of Dr. Celsa Pinto Vs. Goa State Information Commission regarding information under the Right to Information Act, 2005.

High Court of Bombay at Goa in the above referred case has held on 3.4.2008 that the term 'information' as defined in the Right to Information Act does not include answers to the questions like 'why'. The relevant part of the judgement is reproduced below:

"The definition of information cannot include within its fold answers to the question "why" which would be same thing as asking the reason for a justification for a particular thing. The public information authorities cannot expect to communicate to the citizen the reason why a certain thing was done or not done in the sense of a justification because the citizen makes a requisition about information. Justifications are matter within the domain of adjudicating authorities and cannot properly be classified as information."

5. Keeping in view the above, the Commission observes that no further action is required to be taken in this case as no directions can be issued to the respondent authority to mention the details as has been requested by the representative of the complainant under the provisions of the RTI Act, 2005. However, the complainant is advised to make a separate application to the authorities concerned in case he wants any changes in the record of the district administration. Since, the information as available on record has already supplied by the respondents as per the statement given by the representative of the respondents during the hearing and nothing more is available on record which could be supplied to the complainant, therefore, the case is disposed of and closed.
