Last opportunity is given to the Appellant and he is advised to point out discrepancies, if any, on the receipt of information and send the same to the PIO/Respondent by registered post with a copy to the Commission, failing which the case will be decided on merits. The Appellant is further advised to appear in person or through any of his representative on the next date of hearing.

This case is adjourned to next date of hearing i.e. 01.10.2019 at 11:00 A.M.

In view of above, PIO O/o The Secretary, Regional Transport Officer, Jalandhar (Punjab) will Show Cause under Section 20 (1) of the RTI Act, as to why penalty be not imposed upon him for willful delay in supplying the information to the RTI Appellant and as to why the compensation be not awarded to the information-seeker under the provisions of the RTI Act, 2005.

In addition, the PIO is also hereby given an opportunity under Section 20(1) provision thereto, for a personal hearing with the sought for information i.e. Schedule details of G.P.F. The request of Appellant has been accepted and her personnel appearance in further hearings be exempted relating to this case. **But the Appellant is advised to write her replies through registered post or through emails to the Respondent/PIO as well as to the Commission before the next date of hearings, so that proceedings can be done easily in future.**
