2. The appellant is absent today and he was also absent on the previous date of hearing without any intimation to the Commission. He is directed to convey discrepancies, if any in the supplied information by registered post within 7 days under intimation to the Commission.

3. The respondent-PIO is directed to supply duly attested information to the appellant after removing the discrepancies by registered post within 7 days under intimation to the Commission.

4. Both the parties are directed to be present personally or through their authorized representative to represent their case.

5. The case is adjourned and fixed for further hearing on **17.09.2020 at 11.30AM** through **CISCO WEBEX MEETING ID No.913428845**. Copies of order be sent to the parties.
