I have gone through the Order dated 21.08.2019 and the appellant was present on that date, but today he has not come present, neither he sent any intimation to the Commission.

Shri Shashi Kapoor, PIO is present today and he has submitted before the Bench that information sought by the appellant regarding Shri Paramjyoti Arora, Superintendent Engineer is personal information and access to this information do not involve any larger public interest, so the information sought by the appellant cannot be provided to him.

I am of the view that information sought by the appellant is personal information of third party and by disclosing this information no larger public interest will be solved in this case, so the PIO has rightly rejected the access to information.

**ORDER**

Shri Jagjit Singh, complainant/applicant has not come present today, however he sent an e-mail and submitted in the e-mail that no information has been provided to him by the PIO as was directed vide Order dated 15.07.2019.

SI Rajesh Kumar is present on behalf of Shri Paramjit Singh Goraya, PPS, PIO and he stated that the PIO has submitted a representation before the Hon'ble Chief Information Commissioner, Punjab and requested him to review the Order dated 15.07.2019 passed by the present Bench .

I have gone through the Order dated 15.07.2019. The information which was sought by the complainant/applicant is connected with the inquiry no.1 dated 23.10.2012 and after the inquiry of the said complaint the FIR No.13 of 2013 was registered at Police Station, Vigilance Bureau, Jalandhar.

It is submitted by the respondent that after the completion of the investigation by the Investigated Officer the challan was put up before the competent court at Hoshiarpur on 29.07.2015. The trial of the said case is still pending before the competent court and the PIO is requesting that as the case is under trial, so information cannot be provided U/s 8(1)(h) of the RTI Act, 2005.

The PIO is seeking exemption under Section 8(1)(h) of the RTI Act, 2005, which is as under :-

“information which would impede the process of investigation or apprehension or prosecution of offenders.”

**Complaint Case No. 377 of 2019**

This exemption is available to the investigation agency in case the investigation is pending and in that case the investigation agency is exempted from providing the information to the information seekers, but in the present case the investigation of the case was completed and after the completion of the investigation the challan was put up before the competent court on 29.07.2015.

The chargesheet/challan was presented before the competent judicial court on 29.07.2015 and it is mandatory as per the provisions of Code of Criminal Procedure 1973 that copies of documentary as well as oral evidence have to be provided to the accused free of cost by the court then opportunity of hearing was provided to the accused on the framing of the chargesheet.

So, I do not agree with the submission of the PIO. Hence, a direction is issued to the PIO that information sought by the complainant/applicant be sent to him through registered post within 10 days and the PIO is further directed that he should personally come present on the next date of hearing along with copy of information and copy of postal receipt.
