1. This order may be read with reference to the order dated 29.06.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Sukhdev Singh, appellant comes present to attend the hearing in person before the Bench.

Patiala to file an affidavit on non judicial stamp paper, within 21 (Twenty one) days, duly signed by the PIO and attested by the Notary Public to the effect that the information as available in the official records in AC No.1277 of 2022 has been supplied to the appellant. It be further stated that the letter No.7320 dated 27.07.2020 was marked by the Estate Officer to the Divisional Engineer, Civil for taking action and no other details are available and the matter is still under consideration. It be further stated that letter No.8873 dated 06.07.2018 could not be traced in the official records. It be further stated that nothing has been concealed therein and the information supplied is true and correct. Original affidavit be sent to the appellant and copy of the same be sent to the Commission for record.

1. This order may be read with reference to the order dated 25.05.2022 passed by this Bench on the previous hearing.
2. The case has been heard today. Shri Gaurav Kumar, appellant comes present to attend the hearing through cisco webex and states that he has been supplied information vide letter dated 25.05.2022, but the same is irrelevant and unsatisfactory. He further states that deficiencies were pointed out to the PIO but no information after removing the deficiencies has been supplied.
3. Neither the PIO O/o Chief Administrator, GLADA, Ludhiana has come present to attend the hearing in person or through cisco webex nor he has deputed any of his representatives to attend the hearing on behalf of the PIO. However, letter dated 30.08.2022 by e.mail has been received from the APIO-cum-Assistant Estate Officer, GLADA that due to visit of Housing and Urban Development Minister to Ludhiana, the PIO may not be able to attend the hearing today and has requested for another date.

4. The Bench observes that the PIO has absented himself for the hearing for the second consecutive time. This indifferent attitude of the PIO is viewed adversely. The PIO O/o GLADA, Ludhiana is issued show cause notice to explain his absence and as to why action should not be taken against him and also as to why penalty should not be imposed in the instant case for failing to appear for the hearing and not supplying complete information to the appellant. He is also directed to file a written reply to the show cause notice as to why the appellant should not be compensated for the mental harassment suffered by him in getting the information.

5. In addition to the written reply, the PIO is hereby given an opportunity u/s 20(1) proviso thereto for personal hearing before the imposition of such a penalty, on the next date of hearing. He may take note that in case he does not file the written reply and does not avail himself of the opportunity of personal hearing on the next date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex-parte.

6. The PIO is directed to supply point-wise information to the appellant, after removing the deficiencies, before the next hearing as also ensure to come present in person before the Bench on the next hearing, failing which, penal consequences shall follow.

7. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 04.10.2022 at 11.30 AM in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
