The SPIO further submitted that the information regarding point no.6 of the RTI application dated 19.11.2019 was also sent to the complainant/applicant vide letter no.1217 dated 21.09.2020.

This is a complaint case filed by the complainant/applicant against the SPIO, whereas the RTI application filed by him is not bonafide. He sought the same information which he had already sought in complaint case no. 661 of 2019 and the information was provided to him by the SPIO in that case. So, no complaint lies against the SPIO.

I remand the present complaint case to the SPIO with the direction that the SPIO should pass a Speaking Order within a week and send the copy of the Order to the complainant/applicant through registered post. In case the complainant/applicant would not be satisfied with the Speaking Order of the SPIO, then he is allowed to file the First Appeal before the First Appellate Authority within 30 days from the receipt of Speaking Order of the SPIO.

With this observation the present appeal case is disposed of and closed.
