### **ORDER:**

This order may be read with reference to the previous order dated 31.08.2021.

2. The Representative of the appellant reiterates his earlier version that demanded information has not been supplied till date by the respondents.

3. The PIO is again absent without any communication to the Commission. He was also absent on 23.06.2021 and 31.08.2021. The Commission takes a serious view of this lapse on the part of respondents for taking orders of the Commission in a casual manner and thus, denying the appellant his legitimate right to get the sought for information. Therefore, viewing the delaying attitude of the respondent-PIO, a **Show Cause Notice** under Section 20(1) of the RTI Act 2005, is issued to him (By name) to explain the reasons through a duly attested affidavit as to why a penalty at the rate of Rs.250/- per day subject to maximum of Rs.25000/- be not imposed upon him for the delay in the supply of information. He is also afforded an opportunity of personal hearing on the next date of hearing before taking any action.
