- 1. The RTI application is dated 11.1.2021 vide which the appellant has sought information regarding action taken on Letter No. 1165CEA/3 dated 2.3.20220, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on 2.3.2021 and Second Appeal was filed in the Commission on 27.4.2021 under Section 19 of the Right to Information Act, 2005. The case was last heard on 7.10.2022.
- 2. Both parties are present. At the last hearing on 7.10.2022, the respondent PIO had requested 10 days to file a suitable reply to the RTI application. The PIO was also reminded that he is already under Show Cause Notice and the Commission will brook no further delay beyond 10 days from that hearing. The respondent PIO-cum-EO, Ludhiana Improvement Trust has failed to comply once again.
- 3. The respondent PIO-cum-EO, Ludhiana Improvement Trust is hereby directed to submit the name, current place of posting, telephone number and other contact details of the PIO incumbent at the time of this RTI application was submitted on 11.1.2021. This must be done within 5 days of this hearing.
- 4. The Commission also deems it fit to award a compensation of Rs. 10,000/- to the appellant Sh. Harbhagat Singh as under:-

In view of the harassment and detriment caused to the appellant, **Sh. Harbhagat Singh**, this Commission deems it appropriate to award a **compensation of Rupees Ten Thousand (Rs. 10,000.00)**. This is to be paid vide a crossed cheque / demand draft, by the Public Authority, in this instance, **the office of Executive Officer, Improvement Trust, Ludhiana**, within 15 days of receiving this order. Proof of payment is to be submitted to this Commission.

- 1. The RTI application is dated **22.6.2020** vide which the appellant has sought <u>information</u> regarding action on the complaint by Harbans Kaur, W/o Late Hardeep Singh, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **28.10.2020**, and Second Appeal was filed in the Commission on **22.7.2021** under Section 19 of the Right to Information Act, 2005.
