1. The RTI application is dated **1.3.2019** vide which the appellant has sought information **regarding the Greenland Kindergarten (School) in Ludhiana in ten points**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **16.4.2019**, and Second Appeal was filed in the Commission on **18.11.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **8.7.2022**.

2. The appellant is absent but has informed the Commission of his inability to attend this hearing.
