2. The representative of the respondents states that the letter of the appellant regarding the complaint against Deputy Education Officer, Ludhiana was forwarded to Secretary Education, Punjab (Education-4) for further necessary action.

The appellant states that the respondent PIO has misread his complaint as he has never complained against Deputy Education Officer, Ludhiana and he has wrongly forwarded his complaint to Secretary Education. He has sought present status of his letter dated 12.7.2021 and a copy of action taken on it. The appellant has sent a letter to the Commission which is taken on record.

After hearing the parties and going through complaint dated 12.7.2021 which is available in the case file, it is ascertained that the respondent PIO has misread the complaint dated 12.7.2021 of the appellant and the same has wrongly been forwarded to Secretary Education (Education-4). The respondent PIO has sent a letter which is taken on record and the same is being sent to the appellant. The representative of the respondents admits the mistake.
