ORDER

This order may be read with reference to the previous order dated 27.8.2020.

- 2. The appellant states that he has received the complete information. He also states that the RTI application was filed with the Public Information Officer o/o the Block Development and Panchayats Officer on 8.1.2019 but vide letter dated 27.8.2020, the complete information has been supplied by the respondents. He requests for the compensation due to harassment.
- 3. After hearing the appellant and going through the facts of the case, the show cause notice was issued to Sh. Gurmeet Singh, Block Development and Panchayats Officer Khadoor Sahib under Section 20(1) and Section 19(8)(b) of the RTI Act, 2005. He has made the submissions received in the Commission through email that he has joined as Block Development and Panchayats Officer Khadoor Sahib on 19.6.2020 and the show cause notice issued to him may be withdrawn, which is taken on record. But the respondent-Public Information Officer is absent today.
- 5. It also appears that the appellant has filed the RTI application on 8.1.2019 and the respondent authority has provided the complete information to the appellant vide letter No. 86 dated 27.8.2020, this has resulted in much avoidable inconvenience and hardship to the appellant. He is, therefore, entitled to be compensated under Section 19(8)(b) of RTI Act 2005 for the loss and detriment suffered by him. In the circumstances, I am of the view that ends of justice would be met if a sum of Rs.5000/- (Rupees Five thousand only) is awarded to the appellant as compensation. I order accordingly.

This amount shall be payable by the Respondent from the State exchequer within fifteen days from the issue of this order under intimation to the Commission.
