1. The respondent PIO-cum-EO is further advised that he still has an opportunity to furnish any remaining information that has not been given with respect to this RTI application, alongwith aforesaid affidavit. The respondent PIO-cum-EO, Sh. Vishaldeep is to be present in person along with the original affidavit and any additional information pertaining to this RTI application on at the next date of hearing on 18.10.2022
