### **ORDER (FOURTH HEARING):**

This order may be read with reference to the previous order dated 24.11.2021.

The Appellant states that she has received the information but after the delay of one year whereas the Respondent is absent without any intimation to the Commission.

The perusal of the record reveals that in this case the appellant has tried her best to get the information from the PIO who failed to provide the information to the appellant within stipulated period. She has been made to run from pillar to post for getting the information, which she could not get even after the notice was issued by the Commission in the Second Appeal. She has suffered unnecessary detriments/harassment in getting the information at the hands of the PIO.

I have also looked into all the facts and circumstances of the case. In my view this is a fit case, where award of compensation under Section 19 (8) (b) is also called for. I have no doubt in my mind that this state of affairs has also come about on account of the absence of adequate machinery for handling the RTI work in O/o District Treasury Office, Ludhiana is thus, responsible for the inadequate handling of the RTI request and in the instant case as well. I, therefore, order that **compensation of Rs. 5000/- (Rupees Five Thousand Only)** be paid to the appellant for the detriments suffered by her.

This amount shall be payable from the funds of O/o District Treasury Office, Ludhiana by way of crossed Cheque/Demand Draft in the name of Smt. Neelam Handa within one month.

## **ORDER (FIFTH HEARING):**

This order may be read with reference to the previous order dated 12.01.2022.

The Respondent states that requisite information has already been supplied to the appellant on 28.01.2021 whereas the Appellant states that he has received incomplete and unattested information from the Respondents.

After examining the case file, it is revealed that PIO has not provided complete information relating to the RTI application of the Appellant. The Appellant has also highlighted that till date complete information has not been provided to him. It clearly shows that there is **a delay of about 10 months** for not supplying the information to the Appellant, which is definitely on a higher side and cannot be given a go by. Besides, the then PIO –cum – XEN, O/o XEN/Executive Engineer, P.W.D. (B&R), Gurdaspur seems totally unmindful and indifferent to the orders issued by the Commission on a number of occasions and he has openly defied the same, before reaching to the conclusion, it is relevant to reproduce the last order of the Commission: -

2. Respondent, Sh. Jatinder Mohan has requested for an adjournment to provide an updated reply pertaining to the information sought by the appellant.
3. In the view of above the Commission grants a last opportunity to the respondent to provide the requisite information to the appellant before the next date of hearing.

## **APPEAL CASE NO. 3560 OF 2021**

Thus, the Commission draws the inference that the PIO, without any reasonable cause, has mala fide delayed information and thus, has rendered himself liable for punishment as provided under the RTI Act, 2005. He was given a number of opportunities to provide the information to the Appellant but he is delaying the matter on one pretext or the other. In these circumstances, **Shri Manmohan, then PIO –cum – XEN O/o XEN/Executive Engineer, P.W.D. (B&R), Gurdaspur** is held guilty of default on the above score.

The facts of this case also proved beyond any doubt that the respondent PIO concerned does not deserve any kind of leniency. Hence, in exercise of the powers conferred by Section 20(1) of the RTI Act, 2005, **a penalty to the tune of Rs. 10,000/- (Rupees Ten thousand only)** is imposed upon Shri Manmohan, then PIO –cum – XEN, O/o XEN/Executive Engineer, P.W.D. (B&R), Gurdaspur to be deducted from his salary, which is to be deposited in the State Treasury under the relevant head.

The Drawing and Disbursing Officer O/o Construction Division, P.W.D. (B&R), Malerkotla, District Sangrur is directed to deduct the amount of penalty of Rs. 10000/- from the salary of Shri Manmohan, PIO –cum – XEN, O/o XEN/Executive Engineer, P.W.D. (B&R), Gurdaspur and now transferred to the O/o XEN/Executive Engineer, Construction Division, P.W.D. (B&R), Malerkotla, District Sangrur and deposited in the State Treasury in the following Head of Account and to report its compliance to the Commission: -

- 0070- Other Administrative Services
- 60 – Other Services
- 0800 – Other Receipts
- 86-Fee under the RTI Act, 2005

After going through the facts available on the record and in view of the request of the Appellant for **awarding him a suitable compensation**, it is true that complete information has not been supplied to the Appellant and the loss and detriment suffered by him during this long period in obtaining the information in the instant case.
