ORDER (FIRST HEARING):

The RTI application is dated 17.03.2021 vide which the Appellant has sought information from the PIO O/o Tehsildar, Kahnuwan, District Gurdaspur on the following 2 points in his RTI application: -

- 1) *Certified copy of sale deed dated 23.12.1999 executed by Jarnail Singh in favour of Lakhwinder Singh S/o Kharaita Singh R/o Village Jhanda Labana, Tehsil and District Gurdaspur.*
- 2) *Certified copy of sale deed dated 18.05.2000 executed by Jarnail Singh in favour of Lakhwinder Singh S/o Kharaita Singh R/o Village Jhanda Labana, Tehsil and District Gurdaspur.*
