

**ORDER**

The RTI request is dated 14.09.2019. First appeal is dated 15.10.2019. Second appeal has been received in the Commission on 20.12.2019.

On the last date of hearing, held on 04.01.2021,

- i) The appellant stated that the respondent PIO had provided the same information, which was already provided by the respondent PIO to him earlier.
- ii) Last opportunity was given to the respondent-PIO concerned to supply the certified copies of the required information to the appellant, as per queries raised by him through his RTI request, through registered post.
- iii) An opportunity was given to the appellant to point out deficiencies, if any, in the information supplied in writing, to the respondent PIO well in time so that the same could be removed by the respondent concerned.

Sh. Harmeet Singh, Junior Assistant-cum-APIO, who appeared on behalf of the respondent PIO in today's hearing, states that remaining information at point no. 06 and 07 of the RTI request has been supplied to the appellant vide dated 02.02.2021. He also intimates the Commission that a reply has also been sent to the Commission vide letter no. 500 dated 02.02.2021, which has been received in the Commission vide Diary No. 2840 dated 05.02.2021. It is taken on record.

The appellant, Sh. Gagandeep Singh Threeke, who appeared in person in today's hearing, states that he has received the information but is not satisfied with the same.

After going through the queries raised by the appellant in his RTI request and the response given by the respondent PIO concerned, it is found that the information supplied by the respondent PIO to the appellant is as per queries raised by him through RTI request.

Since the information stands supplied in the instant appeal case and no cause of action is left in this case, hence, the show-cause issued to the concerned respondent PIO vide orders dated 15.06.2020 is <u>dropped</u> and the case is announced as <u>disposed of and closed</u>.
