Tejinder Singh expressed his dissatisfaction and intimated the Commission that he filed RTI application on 01.06.2020 and respondent denying to supply the demanded information with the reference of ਭਾਰਤ ਸਰਕਾਰ ਦੇ ਪੱਤਰ ਨੰਬਰ 120/2009-IR ਮਿਤੀ 23.06.2009. He added that after 01 year department is replying to the RTI application and requested the Commission to supply the demanded information.

One opportunity was granted to respondent PIO to supply the information to the appellant within a week's time under intimation to the Commission. The appellant shall intimate any ambiguity on its receipt to respondent department as well as the Commission before next date of hearing. Matter was adjourned for further hearing on 31.03.2022.

2. In today's hearing, both the parties are present. Respondent, Gurbax Singh states that the information has already been supplied on 29.3.2022 via an email and registered post.
3. Appellant is advised to point out deficiency, if any, on its receipt under intimation to the Commission within one week. Respondent PIO is also directed to remove deficiency, if any, pointed out by the appellant within seven days after receipt letter regarding deficiency.
4. This case is adjourned to **04.08.2022 at 11:00 A.M. through CISCO WEBEX application** and both the parties are directed to be present on the next date of hearing. Copy of the order be sent to the parties through registered post.
