- Provide me certified copy of dispatched register where verification of certificates are dispatched from 18-09-2013 to 30-09-2013. In which dispatch number 11577 falls set number 3 & 13.
- Provide me certified copy of that verification letter which were sent to <u>SUPERINTENDENT PUNJAB</u> <u>GOVT. GENERAL ADMINISTRATION DEPARTMENT SECTRIATE AMLA -2 BRANCH CHANDIGARH</u> 160001. In response to verification letter number 2/3/2011-4 AMLA-2 Part file 19265 dated 22-07-2013.
- Provide me certified copy of letter number 2/3/2011-4 AMLA-2 Part file 19265 dated 22-07-2013 addressed to Your office for verification from SUPERINTENDENT PUNJAB GOVT. GENERAL ADMINISTRATION DEPARTMENT SECTRIATE AMLA -2 BRANCH CHANDIGARH.
- Provide information about the name of school and district where roll number 268010 of matriculation for the year march 2003 falls.
- Respondent PIO sent latest information to the appellant vide letter no. 246 dated 18.10.2021 comprising 08 pages, which is received by the undersigned Bench through an email dated 21.10.2021, which is on record.
