3. Appellant is absent for today's hearing but an email has been received in the Commission from email id [ramansalary78@gmail.com](mailto:ramansalary78@gmail.com) on 26.07.2019 for exemption of his presence from today's hearing. This email is considered and is taken on record.
4. After hearing the respondent and after going through the documents placed on record, the appellant is directed to visit respondent's office on any working day during working hours and collected the copy of requisite information as bulk information has been requisite, failing to which the case would be decided on merit basis.
5. The case is adjourned to **21.08.2019 at 11.00 AM** for further proceedings.
