#### **ORDER**

Heard through facility of Software/application 'CISCO Webex Meetings'.

This case was earlier fixed for hearing for 18.02.2020 and adjourned for 12.05.2020 (was postponed) and fixed for hearing for today i. e. 31.08.2020. On that hearing, held on 18.02.2020, Sh. Kuldeep Singh, Senior Assistant, appeared for the respondent PIO and stated that a reply has been sent to the appellant, intimating him that the information sought for by him through RTI request could not be supplied to him as it is 'third party' information. After examining the documents placed on record, it was found that information sought for by the appellant is not 'third party or personal information'. Accordingly, the respondent-PIO was directed to supply the certified copies of the required information to the appellant as per queries raised by him through RTI request and an opportunity is also given to the appellant to point out deficiencies, if any, in the information, which would be supplied to him by the respondent PIO, in writing, to the respondent PIO well in time so that the same could be removed by the respondent concerned.

The respondent PIO through a reply vide letter no. 564 dated 24.08.2020 signed by Public Information Officer-cum-General Manager, P. R. T. C., Kapurthala, which has been received in the Commission vide Diary No. 10794 dated 28.08.2020, has intimated the Commission that complete information has been supplied to the appellant vide letter no 64 dated 09.06.2020, appended to which is a note dated Nil signed by the appellant as an acknowledgement of having received the requisite information, through which he claimed that he is satisfied with the information supplied and asked for filing of his case. It, alongwith annexure, is taken on record.

As the appellant has given his consent to close the case, the case is **disposed of and closed.**
