The appellant is present today, whereas none has appeared on behalf of the SPIO. The appellant stated that he has filed RTI application on 22.12.2020 and sought information regarding Gram Panchayat, Amir Khas, Block Guruharsahai through four points, but neither the information nor the amount of compensation of Rs.2,000/- has been provided to him by the SPIO.

I have gone through the Order dated 07.07.2021 and a compensation of Rs.2,000/- was awarded in favour of the appellant and the SPIO was directed to send the same to the appellant from the funds of public authority by way of demand draft through registered post within 15 days along with attested copies of sought for information.

But the SPIO is absent today and neither he has complied with the Order of the Commission. He was absent on 07.07.2021 and today again he is absent without any intimation to the Commission. The conduct of the SPIO amounts to denial of information and defiance of the provisions of the RTI Act, 2005. So, a show cause notice is issued to the SPIO, O/o BDPO, Guruharsahai, Distt. Ferozepur that why you have not provided the sought for information to the appellant within the stipulated period and so why you may not be penalized upto Rs. 25,000/-U/s 20(1) of the RTI Act, 2005.

The SPIO is hereby directed to file reply to the show cause notice and send the same to the Commission within 15 days and an opportunity of personal hearing will be afforded to him on the Show Cause Notice on the next date of hearing. In case the SPIO would not file

reply to the Show Cause Notice, then it will be assumed that he do not want to say anything in his defence and the show cause notice will be decided in his absence and he will be penalized upto Rs. 25,000/- which will be deducted from his salary.

The SPIO is further directed that the attested copies of information and the amount of compensation of Rs. 2,000/- from the funds of public authority by way of demand draft be sent to the appellant within 15 days through registered post and compliance be sent to the Commission.
