Sh. Paramjit Singh, Regional Manager, who appeared on behalf of the respondent PIO in today's hearing, states that a point-wise reply vide letter no. 2052 dated 01.02.2022 has already been given and a copy of the same I placed in the case-file.

The complainant, Sh. Madan Lal, who appeared in person in today's hearing, states that incomplete information has been given to him by the respondent PIO.

Nevertheless, the appellant is advised to visit the office of the respondent PIO today itself i. e. 31.08.2022 to at 03:00 P. M. to collect the information.

The respondent PIO concerned is directed to facilitate the appellant during his visit to the office and supply the remaining information to the appellant with a copy to the Commission.

With the above-announced directions, the show-cause issued to the concerned respondent PIO vide orders dated 25.01.2021, is dropped and the instant complaint-case is announced as disposed and closed.
