1. The RTI application is dated **7.12.2020** vide which the appellant has sought information **regarding work orders, agreements, and sample test reports of all roads constructed in Ward Number 94 since 2017**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **11.1.2021** and Second Appeal was filed in the Commission on **20.5.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **14.10.2022**.

2. Both parties are present. As per the appellant, the respondent PIO once again submitted only partial information with regard to the deficiencies listed by him. The respondent PIO, represented by Ashwani Kumar Sikka, APIO-cum-SDO and Sandeep Kumar, JE from Zone A, state that the pending information with regard to Sunil Nagar is not traceable and that two employees have been assigned the task of searching the said information.

3. The respondent PIO is directed to arrange an **inspection** of the record with regard to the genuine information pertaining to Sunil Nagar at 11.00 am on 4.11.2022 and provide all copies sought by the appellant after said inspection, Sh. Ashwani Kumar Sikka, APIO-cum-SDO and Sh. Sandeep Kumar, JE, are hereby directed to be personally present during the aforesaid inspection to assist the appellant. The appellant is requested to inform the Commission after inspection.
