3. The representative of the complainant submits that three directions may be issued to the respondent-Public Information Officer to supply the complete information in this case. Sh Balwinder Singh also made the oral submissions and also tenders unconditional apology regarding delay due to unforeseen situation, in this case. Furthermore, he has requested to withdraw the penalty imposed.

3. It is appropriate to mention that Hon'ble Supreme Court of India in its order rendered on 12.12.2011 in Civil Appeal Nos.10787 – 10788 of 2011 (arising out of SLP © No.32768-32769/2010) has held that while entertaining a complaint under Section 18 of the RTI Act, 2005, the Commissioners have no jurisdiction to pass an order providing for an

access to the information. Since the complainant has approached the Commission under the provisions of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission.

An alternative and efficacious remedy of first appeal is available to the complainant under Section 19(1) of the RTI Act, 2005 which has not been availed in the instant case. Since the complainant is interested in getting the information, therefore, the matter is remanded back to Sh. Jagdeep Singh, Block Development and Panchayats Officer-cum- First Appellate Authority to take appropriate decision in accordance with the provisions of the RTI Act within the prescribed timeline, after giving opportunity of hearing to all concerned by passing a speaking order. A copy of this complaint filed by the complainant is also **being sent** to the First Appellate Authority along with this order with the directions to treat the same as first appeal. Also, after consideration the submissions made by Sh. Balwinder Singh, Panchayat Secretary, the penalty imposed upon him, is hereby withdrawn in this case.

5. Accordingly, the case is disposed of and closed. However, the liberty is granted to the complainant/appellant to file the 2nd appeal in this case, if he is not satisfied with the decision of the First Appellate Authority.

3. The appellant submits that the M/s Goyal Constructions was already blacklisted/debarred by the Administrator-cum-Sub Divisional Magistrate vide letter No. 274 dated 10.3.2021. He also submits that he has sought the information as the firm has been enlisted directly in Class-2 whereas the firm does not have any Class III or Class IV enlistment. In addition he also submits that without having Class III or Class IV enlistment no firm can be granted directly Class 2 enlistment. He also brought to the notice that in case the firm enlisted for Class III and IV from other public authority than only that public authority can renew the enlistment for class 2 only and no other public authority can give the benefit of some other authority for the enlistment. The appellant also sent the written submissions in support of his claim along with the letter dated 10.3.2021 and requested to direct the respondent to supply the complete information in this case.

4. In accordance with the Punjab RTI Rules, 2017 and in the interest of natural justice, M/s Goyal Constructions was also impleaded as necessary party in this case as the appellant is seeking the information related to M/s Goyal Constructions. None is present on behalf of M/s Goyal Constructions but the response has been received from the said party and the relevant part of the same is reproduced below:-

The reply on behalf of Goyal Constructions:-

This is reference to your Letter No. RRSA/MCorp., AMR/29-07/2020-2021 dated 29.07.2021/ 02.08.2021 wherein Ramandeep Singh Ahluwalia, R/o # 458, Ward No.18, Street No.2, Kartar Nagar, Amloh Road, Khanna (Pb) who has sought information from Sr.No.1 to No.4 from public information officer, Municipal Corporation, Amritsar. This is to inform you that the same should not be supplied to him as the same is third party information and Goyal Constructions have objection with the same. Further, as per Letter No. 4/52021-4GR1/1/225467/2021 issued by Govt. of Punjab, Department of Governance Reforms & Public Grievances (Governance Reforms-1 Br.) dated Chandigarh the 09.08.2021 and as per decision dated 13.11.2019 of Hon'ble Supreme Court of India in Civil Appeal No, 10044 of 2020 titled in "Central Public Information Officer, Supreme Court of India Vs. Subash Chandra Agarwal" Regarding Right to Information Act, 2005", the same could not be supplied to the applicant/appellant

Ramandeep Singh Ahluwalia as the information sought by him falls under Section 11 of the RTI Application of the undersigned falls under third party and hence should not be disclosed to any other person not related with supplying of the information. Further, Section 11(1), reference is made to the 'possible' harm and injury to the third party which will also have to be factored in when determining disclosure of confidential information relating to the third parties. Section 8(d) of Right to Information Act is also applicable here, where the information including commercial confidence, trade secrets or intellectual property, the disclosure of which would harm the competitive position of third party is exempted from disclosure of information. The Hon'ble Punjab & Haryana High court in Civil Writ Petition no.17543 titled as Rajan Verma vs Union of India held that the personal information is exempted from disclosure under the Right to Information Act. It is important to mention here that the applicant/appellant is a habitual of harassing the innocent people by misusing the tool of Right to information. The applicant/appellant filed the RTI application just to harass and humiliate owner of Goyal Constructions without any cause or reason. The applicant/appellant used to file frivolous RTI applications against different persons for extorting money from them. Due to the above said illegal acts of the applicant/appellant Ramandeep Singh Ahluwalia, one Ambika Pandit contractor contacted with Vigilance Department, Mohali. On 19.05.2018, the Vigilance Department, Mohali

caught the applicant/appellant Ramandeep Singh Ahluwalia while taking bribe and lodged a case against the applicant vide FIR No. 5 dated 19.05.2018 U/s Corruption Act, Section-8, Police Station, Vigilance Bureau, FS-1, Punjab, Mohali. The present RTI application is false and baseless and the applicant/appellant is not entitled for the said information because it relates to a third party information. As per settled law this information cannot be given to the applicant.

5. Although the parties concerned have made the submissions in support of their claim but the issue before the Commission is to decide whether the sought information should be supplied to the appellant related to M/s Goyal Constructions or not ?

6. It is appropriate to mention here the decision of the Hon'ble Supreme Court of India in Civil Appeal No. 10044 of 2010 – Central Public Information Officer, Hon'ble Supreme Court of India Vs Subhash Chandra Agarwal, being the personal information. The relevant portion of the judgement is reproduced below:-

“59. Reading of the aforesaid judicial precedents, in our opinion, would indicate that personal records, including name, address, physical, mental and psychological status, marks obtained, grades and answer sheets, are all treated as personal information. Similarly, professional records, including qualification, performance, evaluation reports, ACRs, disciplinary proceedings, etc. are all personal information. Medical records, treatment, choice of medicine, list of hospitals and doctors visited, findings recorded, including that of the family members, information relating to assets, liabilities, income tax returns, details of investments, lending and borrowing, etc. are personal information. Such personal information is entitled to protection from unwarranted invasion of privacy and conditional access is available when stipulation of larger public interest is satisfied.

7. It is also appropriate to mention Section 10 which provides –

(1) Where a request for access to information is rejected on the ground that it is in relation to information which is exempt from disclosure, then, notwithstanding anything contained in this Act, access may be provided to that part of the record which does not contain any information which is exempt from disclosure under this Act and which can reasonably be severed from any part that contains exempt information.

(2) Where access is granted to a part of the record under sub-section (1), the Central Public Information Officer or State Public Information Officer, as the case may be, shall give a notice to the applicant, informing—

(a) that only part of the record requested, after severance of the record containing information which is exempt from disclosure, is being provided;

(b) the reasons for the decision, including any findings on any material question of fact, referring to the material on which those findings were based;

(c) the name and designation of the person giving the decision;

(d) the details of the fees calculated by him or her and the amount of fee which the applicant is required to deposit; and

(e) his or her rights with respect to review of the decision regarding non-disclosure of part of the information, the amount of fee charged or the form of access provided, including the particulars of the senior officer specified under sub-section (1) of section 19 or the Central Information Commission or the State Information Commission, as the case may be, time limit, process and any other form of access.

8. According to the reply filed by M/s Goyal Constructions, mentioned herein, no specific submission has been filed which justifies the claim that the sought information may not be supplied to the appellant. On the other hand, the submissions made by the appellant, as enumerated in para 3 above, outweigh the submissions made by M/s Goyal Constructions. This Act confers very important and valuable rights upon a citizen. Also, the mandate of the RTI Act, 2005 is to provide for setting out the practical regime for citizens to secure access to information under the control of public authorities, in order to promote transparency and accountability in the working of every public authority.

9. After going through the submissions made by the parties viz a viz RTI application of the appellant, in accordance with the provisions of the RTI Act, 2005 and keeping in view the above, the Commission is of the view that the information pertaining to Point No. 1 to 3 of the RTI application be supplied to the appellant as the larger public interest warrants except the personal information invoking Section 10 of the RTI Act, 2005, as enumerated above. Regarding Point No. 4 of the RTI application of the appellant, the directions are issued to supply the same else a specific reply be sent to the appellant in this regard. As such, the directions are issued to the respondent-Public Information Officer to supply the information sought by the appellant within 10 days from the receipt of this order.

10. Accordingly, the case is disposed of and closed. sd/
