ORDER:

1. The RTI application is dated **23.11.2020** vide which the appellant has sought information **regarding suspension of Surjit Singh, Building Inspector in Zone B**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **4.5.2021** and Second Appeal was filed in the Commission on **1.7.2021** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **31.8.2021**.
