ORDER

This order may be read with reference to the previous order dated 11.8.2021.

2. The appellant has sought the following information:-

“Kindly provide me the full information about the day by day present status of filed Complaint which I filed to the Tehsildar, West (EP 586327916IN) dated 14.1.2019.”

3. The appellant states that he has received the complete information except the copy of order in rapat No. 415 dated 4.1.2020 and action taken on the complaint filed by him on 14.1.2019. However, the representative of the respondents sent the letter dated 25.8.2021 vide which it has informed that the matter has already been sent to the Kanungo Sunet. The relevant portion of the same is reproduced below:-

”...ਜਗਜੀਤ ਸਿੰਘ ਪੁੱਤਰ ਹਰਬੰਸ ਸਿੰਘ ਵਾਸੀ ਅਮਨ ਨਗਰ ਗਲੀ ਨੰ: 3 ਬੈਕ ਸਾਈਡ ਗਰੀਨ ਲੈਂਡ ਸਕੂਲ ਨੇੜੇ ਜਲੰਧਰ ਬਾਈਪਾਸ ਲੁਧਿਆਣਾ ਵੱਲੋਂ ਦਿੱਤੀ ਗਈ ਦਰਖਾਸਤ ਤੇ ਕੀਤੀ ਗਈ ਕਾਰਵਾਈ ਬਾਰੇ ਜਾਣਕਾਰੀ ਦੀ ਮੰਗ ਕੀਤੀ ਹੈ। ਇਹ ਦਰਖਾਸਤ ਇਸ ਦਫਤਰ ਵਲੋਂ ਨੰ: 199 ਮਿਤੀ 31.1.2020 ਰਾਹੀਂ ਆਪ ਨੂੰ ਭੇਜੀ ਗਈ ਸੀ। ਆਪ ਨੂੰ ਲਿਖਿਆ ਜਾਂਦਾ ਹੈ ਕਿ ਉਕਤ ਪੱਤਰ ਤੇ ਕੀਤੀ ਗਈ ਕਾਰਵਾਈ ਬਾਰੇ। ਇਸ ਦਫਤਰ ਨੂੰ ਜਾਣੂ ਕਰਵਾਇਆ ਜਾਵੇ ਤਾਂ ਜੋ ਸੂਚਨਾ ਪ੍ਰਾਰਥੀ ਨੂੰ ਮੁਹੱਈਆ ਕਰਵਾਈ ਜਾ ਸਕੇ....। ”

4. The appellant further states that he has filed the complaint related to his own property but the respondent authority is not taking any action on the complaint filed by him which has been considerably delayed.

5. As far as the copy of the Court Orders in CM 7866 C 2018 in RSA No. 5587 of 2017 in Ashok Kumar Vs Jagjit Singh is concerned, the same are available on the website of the

Hon'ble Punjab and Haryana High Court, therefore, no direction is being given to the respondent authority. A copy of the order downloaded from the website i.e. [www.highcourtchd.gov.in](http://www.highcourtchd.gov.in) is also being **sent** along with this order.

6. Keeping in view the submissions made by the appellant, the Commission is of the view that the respondent authority should have taken the appropriate action on the complaint dated 14.1.2019. Therefore, the copy of this order along with the letter dated 25.8.2021 and RTI application is being **sent** to the Deputy Commissioner, District Ludhiana to look into the matter personally and take appropriate action as per Law preferably within four weeks, since the complaint filed by the appellant related to his own property. With these directions, the case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within six weeks in case no response has been received from the respondents in this regard.
