2. Both parties are present. The appellant is present in person. The respondent PIO represented by Muneet Sharma, JE, requests some additional time to search for the requested record. He is hereby granted Four weeks from the date of receipt of this Order to supply the requested information. Said information must be accompanied by a covering letter by way of a pointwise reply with the points listed in the RTI application on the left with the respondent PIO's reply and details of the information and documents being supplied on the right.
