1. The RTI application is dated **28.9.2019** vide which the appellant has sought **information regarding action on the application given by Surinderpal Singh against Rajinder Kaur**, as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (FAA) on **29.11.2019**, and second appeal was filed in the Commission on **20.1.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **17.9.2020**.
2. Both the parties are present. The respondent PIO, represented by ASI Gian Singh, handed over some of the information requested in the RTI application. However, the appellant Rajinder Kaur, represented by her husband Bachhitar Singh, is not satisfied and says that the information supplied is incomplete. Meanwhile, in a letter dated 27.10.2020, the respondent PIO-cum-SHO, Police Station, PAU has also sent a reply to this Commission.
3. This Commission directs the respondent PIO to supply all the information that is listed as deficient by the appellant at the earliest after attesting every page of the information furnished. The respondent PIO-cum-SHO, Police Station, PAU is also directed to submit a duly Notarized Affidavit in reply to the RTI application. The appellant has stated that the enquiry report sought by him has not been furnished as yet.
