On being queried about this, the respondent PIO's representative at today's hearing, Sh. Balraj Singh, JA, only states that the subject matter of both RTI applications is the same. Sh. Balraj Singh's contention is hereby rejected.
- 3. Meanwhile, the PIO-cum-Secretary, District Legal Services Authority, Smt. Manpreet Kaur, has made a detailed written submission vide Letter No. 2619 Dated 2.11.2022, to explain the delay in addressing the RTI application Dated 7.10.2021. The Commission has examined the PIO's reply and herewith directs her to submit the same along with any additional submission by way of a duly notarized affidavit, to the Commission. This must be done within 10 days of receipt of this Order.
