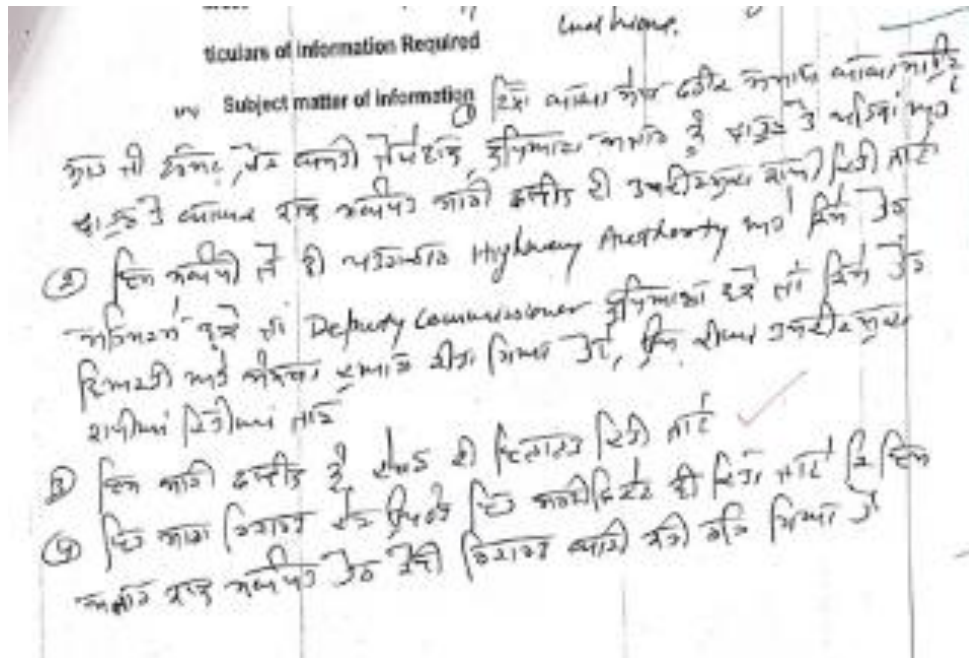

2. The appellant has sought the following information:-



3. The representative of the respondents submits a copy of the complete file concerning the sought information.
