rightly denied by the Public Authority under Section 8(1)(j) of the Right to Information Act, 2005.

5. It is pertinent to mention here that as per the **Girish Ramchandra Deshpande's** vs. CIC and others (SLP (C) no. 27734/2012) decided by the Hon'ble Supreme Court of India, the petitioner sought information of the employee and in which it was held as under:-

"12. ...The performance of an employee/officer in an organisation is primarily a matter between the employee and the employer and normally those aspects are governed by the service rules which fall under the expression "personal information", the disclosure of which has no relationship to any public activity or public interest. On the other hand, the disclosure of which would cause unwarranted invasion of privacy of that individual......"

6. It is also appropriate to mention the decision rendered by the Hon'ble Supreme Court of India in Civil Appeal No. 10044 of 2010 – Central Public information Officer, Supreme Court of India Vs Subhash Chandra Agarwal and the relevant portion of the same is reproduced below:-

"59. Reading of the aforesaid judicial precedents, in our opinion, would indicate that personal records, including name, address, physical, mental and psychological status, marks obtained, grades and answer sheets, are all treated as personal information. Similarly, professional records, including qualification, performance, evaluation reports, ACRs, disciplinary proceedings, etc. are all personal information. Medical records, treatment, choice of medicine, list of hospitals and doctors visited, findings recorded, including that of the family members, information relating to assets, liabilities, income tax returns, details of investments, lending and borrowing, etc. are personal information. Such personal information is entitled to protection from unwarranted invasion of privacy and conditional access is available when stipulation of larger public interest is satisfied."

7. Keeping in view the judicial pronouncements and specific reply filed by the respondent as enumerated above, the Commission accepts the same and is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed. sd/



Therefore, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within three weeks, if he does not receive the same.

ORDER

Present:-

The RTI application is dated 9.4.2022 vide which the complainant has sought information as enumerated in his RTI application. Complaint was filed in the Commission on 27.4.2022 under Section 18 of the Right to Information Act, 2005 (hereinafter called RTI Act). Notice of hearing was issued to the parties for today. The complainant filed the case under the life and liberty clause as she has retired one year back and her dues have not been cleared.

2. The complainant submits that the directions may be issued to the respondent-Public Information Officer to supply the complete information.

3. It is appropriate to mention that Hon'ble Supreme Court of India in its order rendered on 12.12.2011 in Civil Appeal Nos.10787 – 10788 of 2011 (arising out of SLP © No.32768-32769/2010) has held that while entertaining a complaint under Section 18 of the RTI Act, 2005, the Commissioners have no jurisdiction to pass an order providing for an access to the information. Since the complainant has approached the Commission under the provisions of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission.

An alternative and efficacious remedy of first appeal is available to the complainant under Section 19(1) of the RTI Act, 2005 which has not been availed in the instant case. Since the complainant is interested in getting the information, therefore, the matter is remanded back to Dr. BS Sandhu, Dean Academic-cum-First Appellate Authority, Punjabi University, Patiala to take appropriate decision in accordance with the provisions of the RTI Act after giving due opportunity of hearing to all concerned by passing a speaking order.

5. With these directions the case is disposed of and closed. However, the liberty is granted to the complainant to file the 2nd appeal in this case, if she is not satisfied with the decision of the First Appellate Authority. A copy of the order is also being sent to the parties through whatsapp/email.
