This order may be read with reference to the previous order dated 3.8.2020 vide which the Public Information Officer o/o the Financial Commissioner, Rural Development & Panchayat Deptt., Pb. was impleaded as necessary party in this case and the case was adjourned to 1.9.2020 but could not be heard due to administrative reasons and further adjourned to 5.10.2020.

2. The appellant states that no information has been provided by the respondents so far. However, the representative of the respondents states that the sought information relates to the personal information which cannot be provided under Section 8(1)(j) of the RTI Act, 2005. Since, the complainant has sought the information concerning Ms. Paramjit Kaur, Addl. Deputy Commissioner (Dev.) she is exempted from further appearance in this case. With regard to the sought information the Commission is of the view that such information should have been in the public domain, hence, the plea taken by the respondent-Public Information Officer is not acceptable at this stage.

3. During the hearing it has transpired that the information in such case(s) is in the office of the Financial Commissioner, Rural Development & Panchayat Punjab. Accordingly Smt. Santosh Rani, Under Secretary-cum-Public Information Officer, is, impleaded as necessary party in this case and is directed to file the reply/supply the information as has been sought by the complainant before the next date of hearing. A copy of the RTI application is again sent with this order.
