ORDER:

1. The RTI application is dated **24.2.2020** vide which the appellant has sought information **regarding his application dated 24.2.2022**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **21.5.2021** and Second Appeal was filed in the Commission on **15.7.2021** under Section 19 of the Right to Information Act, 2005. Notice was issued to the parties for first hearing in the Commission on **5.4.2022**.

2. The appellant is absent but has informed the Commission that he has received the requested information. The respondent PIO has submitted a copy of his reply and the appended information, to this Commission vide Letter No. 48/RTI Dated 21.1.2021. The appellant contends that the requested information was inordinately delayed. This RTI application filed on 24.2.2020 and the respondent PIO first sent a reply/information on 21.7.2021.

3. The Commission notes that this RTI application was made just ahead of the statewide restrictions imposed in the wake of the Pandemic. The delay is condoned. There is no further cause for action and this Appeal Case is herewith **CLOSED**.
