- 7. Keeping in view the response filed by the respondent enumerated above, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed.

- (viii) The attested copies of all the resolutions passed or made entry in the Resolution Register by the present Sarpanch or gram panchayat of village Kamagar.
- 3. The appellant submits that he has received the compensation as has been awarded by the Commission amounting to Rs.5000/-. Regarding information he submits that the respondent Panchayat Secretary has to supply a copy of the bank statement pertaining to 8 months of Punjab National Bank and the complete bank statement pertaining to HDFC bank up to 2020. Also, the respondent Panchayat Secretary assures that the remaining bank statements will be supplied to the appellant within a week.
- 4. According to the assurance given by the respondent, the directions are issued to the respondent Public Information Officer to supply the remaining photocopies of the bank statements duly certified as a enumerated above within two weeks to the appellant through registered post with a copy to the Commission.
