ORDER

This order may be read with reference to the previous order dated 4.8.2020 vide which the case was adjourned to 6.10.2020 but due to administrative reasons, the case was further adjourned for today i.e. 6.10.2020.

2. The appellant has sought the following information as per his RTI application:-

”ਮਿਤੀ 8.4.2019 ਨੂੰ ਬਜਰੀਆ ਰਜਿਸਟਰਡ ਡਾਕ ਰਾਹੀਂ ਦਿੱਤੀ ਦਰਖਾਸਤ ਜੋ ਆਪ ਜੀ ਦੇ ਦਫਤਰ ਵਿੱਚ ਡਿਸਪੈਚ ਨੰਬਰ 14 ਮਿਤੀ 10.4.2019 ਰਾਹੀਂ ਦਰਜ ਹੈ, ਤੇ ਕੀਤੀ ਗਈ ਕਾਰਵਾਈ, ਦੋਨਾਂ ਧਿਰਾਂ ਦੇ ਬਿਆਨਾਤ ਅਤੇ ਸਿੱਟਾ ਰਿਪੋਰਟ ਦੀ ਤਸਦੀਕਸੁਦਾ ਸੂਚਨਾਂ ਲੈਣ ਬਾਰੇ। ਦ/ਵੱਲੋਂ ਦਸਵੀਰ ਸਿੰਘ ਪੁਤਰ ਜੋਗਿੰਦਰ ਸਿੰਘ ਸਰਖਿਲਾਫ ਜਸਵਿੰਦਰ ਕੌਰ ਸਾਬਕਾ ਸਰਪੰਚ ਗਰਾਮ ਪੰਚਾਇਤ ਮੇਘਾ ਪੰਜ ਗਰਾਈਂ ਹਿਠਾੜ ਬਲਾਕ ਤਹਿਸੀਲ ਗੁਰੂਹਰਸਹਾਏ ਜਿਲਾ ਫਿਰੋਜ਼ਪੁਰ”

3. The respondent authority has submitted a copy of letter No. 2086 dated 19.5.2020, which is taken on record vide which Director, Rural Development & Panchayat Deptt., Pb. has been written to take the disciplinary action against Smt. Jaswinder Kaur Ex-Sarpanch, Gram Panchayat Megha Panj Garai Hithar and Sh. Chanda Singh, Panchayat Secretary on the complaint filed by Sh. Jasveer Singh.

4. Since, the respondent authority has suitably replied and provided the copy of action taken on the complaint filed by the appellant. Copy of the letter dated 19.5.2020 is sent with this order. Therefore, the Commission observes that no more action is required in this case and the case is disposed of and closed.
