This order may be read with reference to the previous order dated 14.10.2020.

- 2. The respondent-Panchayat Secretary states that he has brought the original record for inspection of the complainant concerning his RTI application except the copies of the bank pass book/statement from 1.1.2019 to 1.7.2019. He also submits the copy of information duly signed along with the forwarding letter, which is taken on record. He also submits the reply of the show cause notice issued to him, which is taken on record. Also the Panchayat Secretary- Sh. Dimple is directed to supply a copy of the bank pass book/statement from 1.1.2019 to 1.7.2019 to the complainant before the next date of hearing and he assured that the same will be supplied to him before the next date of hearing. Sh. Dimple orally states that his wife was not well so he could not submit the reply of the show cause notice issued to him and submits the unconditional apologies for the same. He also submits the copy of a written reply of the show cause notice along with an annexure, which is taken on record. Show cause notice was also issued to Sh. Narbhinder Singh, District Development and Panchayats Officer. In compliance his reply has already been received in the Commission. Therefore, the decision regarding show cause notice issued to Sh. Narbhinder Singh, District Development and Panchayats Officer and Sh. Dimple, Panchayat Secretary will be taken on the next date of hearing.
- It is also a fact on record that a show cause notice was issued to Sh. Shavinder Singh, Block Development and Panchayats Officer. Block Andana at Munak-cum-deemed Public Information Officer. As the complainant has sought the information from the



District Development and Panchayats Officer, Sangrur since the custodian of the record was directly working under the control of Sh. Shavinder Singh, Block Development and Panchayats Officer, he was called being the deemed-Public Information Officer. He was present during the hearing on 24.6.2020 and assured that the complete information will be supplied to the complainant before the next date of hearing and requested for the adjournment of the case. So the case was adjourned to 14.7.2020. But due to administrative reasons the case was further adjourned to 13.8.2020. During the hearing on 13.8.2020, due to non providing of information and the conduct of the respondent deemed-Public Information Officer compelled the Commission to issue him a formal show cause notice which was served to Sh. Shavinder Singh, Block Development and Panchayats Officer on 13.8.2020 as to why action under Section 20(1) of the RTI Act 2005 should not be taken against him and he was also provided an opportunity to file his written reply and also make use of opportunity of personal hearing under the principles of natural justice. A show cause notice was sent to Sh. Shavinder Singh, Block Development and Panchayats Officer through registered post and the case was adjourned to 2.9.2020.

- 5. On the next date of hearing a request bearing No. 1266 dated 2.9.2020 was received from the office of the Block Development and Panchayats Officer, Andana at Munak (Sangrur) that the Block Development and Panchayats Officer, Sh. Shavinder Singh is ill and unable to attend the hearing. Therefore, he has requested for the adjournment of the case. After accepting the request of the respondent's office of Block Development and Panchayats Officer, the case was adjourned by giving the last opportunity to Sh. Shavinder Singh, Block Development and Panchayats Officer to file the reply of the show cause notice issued to him and directions to supply the complete information to the complainant before the next date of hearing and the case was adjourned to 14.10.2020. During the hearing the Block Development and Panchayats Officer Sh. Shavinder Singh remained absent and did not submit the reply of the show cause notice issued to him.
- 6. Even though taking the lenient view, one more opportunity was granted to the Block Development and Panchayats Officer Sh. Shavinder Singh to file the reply with regard to show cause notice issued to him along with the directions to the parties to remain present along with the original record at Chandigarh and the case was adjourned to 6.11.2020.
- 7. During the hearing on 6.11.2020, Sh. Shavinder Singh, Block Development and Panchayats Officer, Andana at Munak remained absent without intimation on the one hand and no reply has been filed by him for consideration regarding the show cause notice issued to him on the other.
- 8. Since the responsibility to ensure the timely supply of information to the complainant lies upon the deemed-Public Information Officer, Shri Shavinder Singh, Block Development and Panchayats Officer, Block Andana at Munak is hereby held guilty for not providing the information on time as prescribed under Section 7 of the RTI Act, 2005 and for repeated and wilful defiance of the Commission's orders to file the reply of the show cause notice issued to him. He has also not availed the opportunity of personal hearing which was offered to him while issuing the show cause notice.

- 9. Such kind of failure on the part of Sh. Shavinder Singh, Block Development and Panchayats Officer is totally unacceptable. It is pertinent to mention here that RTI Act has been enacted to ensure participative nature of management between the public & the public authorities and also to know as to what is happening behind the closed doors with regard to the governance affairs of the public authorities and their functioning.
- After giving thoughtful consideration and due perusal of the facts of the case and the 10. material available on record, I have come to the conclusion that he has failed to perform his duty as per the mandate of the RTI Act, which requires the public servant to ensure due transparency and accountability in its functioning. It has also come out that he has not only failed to perform his duty at his own level but also has shown his casual approach in complying with the explicit order of the Commission.
- It has been further established from his conduct that he has failed to make an effort to provide the information even after getting formal show cause notice from the Commission. This speaks volumes as to how much respect & regard he has in his mind to the provisions of the RTI Act, which mandates that all public authorities will ensure that the RTI Act, 2005 is duly implemented by them, whenever any citizen approaches the public authority to get any public information for which they have right to ask for as per the provisions of RTI Act. In view of the facts mentioned herein, I am of the considered view that Shri Shavinder Singh, Block Development and Panchayats Officer, Block Andana at Munak should be penalised for his negligence in discharge of his statutory duty prescribed under the RTI Act.
- 12. All his failure makes me believe that his sheer neglect to perform his duties will be met only after he is duly taken to task as per the provisions of the RTI Act. Under these circumstances, I am left with no other option but to recommend a disciplinary action against Sh. Shavinder Singh, Block Development and Panchayats Officer, Block Andana at Munak, Sangrur. Therefore, the Financial Commissioner, Rural Development & Panchayat Deptt., Pb. is directed to inform the Commission after taking the disciplinary action against the erring officer.
- 13. To come up on 15.12.2020 at 12.30 PM to be heard through Video Conference Facility available in the office of the Deputy Commissioner, Sangrur/cisco webex.
