ORDER

This order may be read with reference to the previous order dated 3.6.2020 vide which the case was adjourned to 17.7.2020 but due to administrative reasons the case could not be heard and further fixed for hearing today i.e. 6.8.2020

2. The representative of the respondents states that the information as sought by the appellant relates to all the Block Development and Panchayats Officers of Ludhiana District. He further States that there are 13 blocks under the District Development and Panchayats Officer and all block offices having their own PIOs. Furthermore, the representative of the respondents states that the letter bearing No. 8808 dated 23.10.2019 has been written to the concerned Public Information Officer in case he wants to seek the information. On the other hand, the appellant states that he has collected the information related to MANREGA & NRLM from the respondents but he has not received the information from the Block Development and Panchayats Officer regarding the grants/schemes for the development of villages by the state government. The appellant also requests for the said letter as mentioned by the respondents. The appellant further requests the Commission that directions may be issued to the respondent authority to supply the information. **A copy of the letter dated 23.10.2019, is attached with the order.**

3. After hearing both the parties and according to the instructions issued by the Ministry of Personnel, Public Grievances & Pensions, Department of Personnel & Training vide O.M. No. 10/2/2008-IR dated 12.6.2008 (**Copy attached**), the Commission accepts the plea taken by the respondent authority and the appellant is advised to file a separate application afresh to the concerned Public Information Officer, in case he wants to seek the information from all the Block Development and Panchayats Officers. No more action is required in the instant case, hence, the case is disposed of and closed.
